### PARTICIPATION REQUIREMENTS

Interested students must be capable of working independently and accepting responsibility. All participants will be expected to learn their music thoroughly prior to the first rehearsal. Music will be mailed by August 14, 2010.

Applicants must have received a NYSSMA score during the 2009-10 school year of at least Excellent (21) for Levels 3 & 4 or A- (90) for Levels 5 & 6 **OR** for those who have not received the required NYSSMA score, please submit a cassette performance tape or CD\* of appropriate repertoire.

Following are the minimum NYSSMA solo levels for each instrument:

- Level 4: Piccolo, flute, oboe, alto saxophone, snare drum
- Level 3: Clarinet, bass clarinet, bassoon, tenor and baritone saxophone, trumpet, French horn, trombone, euphonium, tuba, percussion (keyboard and timpani)

### FIRST CHAIR OPPORTUNITIES

To be considered for first chair placement in a section, submit a cassette performance tape or CD\* indicative of current playing level (maximum length of 10 minutes).

\*PLEASE label all tape or CD submissions with one or both of the following: (a) Replacement for NYSSMA scores

## ABOUT THE DIRECTORS

**Casey Springstead** earned his Bachelor's and Master's degrees from the Eastman School of Music. Since 1999, he has been an instrumental music teacher in the West Irondequoit Schools, where he is the director of two bands at Dake Jr. High School, and co-director of the Irondequoit High School Wind Ensemble. He has conducted the Irondequoit Concert Band, the Brighton Symphony Orchestra, and the Hochstein Youth Symphony Orchestra as well as a performance of the New Horizons Band in Rochester. In addition to being a member of the horn section in the Penfield Symphony Orchestra, he has performed with several freelance orchestras and bands in the Rochester area. Mr. Springstead also teaches private horn students and is active as a collaborative pianist. He is the director of the Youth Wind Symphony and the Junior Wind Symphony at the Hochstein School of Music & Dance, where he also serves as the Assistant Director of the Philharmonia and as a member of Hochstein's faculty contemporary music ensemble, Twenty21. Mr. Springstead joined the Hochstein faculty in 2003.



**Kirsta Rodean**, a native of the Dallas area, first came to Rochester as a student at the Eastman School of Music where she earned both her Bachelor's and Master's degrees. Ms. Rodean currently serves as a middle school band director for the Fairport CSD and a bassoon instructor at the Hochstein School of Music & Dance. Ms. Rodean has performed as a bassoonist with the Rochester Philharmonic Orchestra, the Wichita Falls (TX) Symphony Orchestra, Kunde Chorale, The Opera Factory, Mercury Opera Rochester, Eastman Philharmonia and Wind Ensemble, and Twenty21, Hochstein's contemporary music ensemble. She has been the Assistant Director of the Hochstein Junior Wind Symphony since 2005.
