
As I begin my 23rd year as a Hochstein staff and faculty member and my first year as

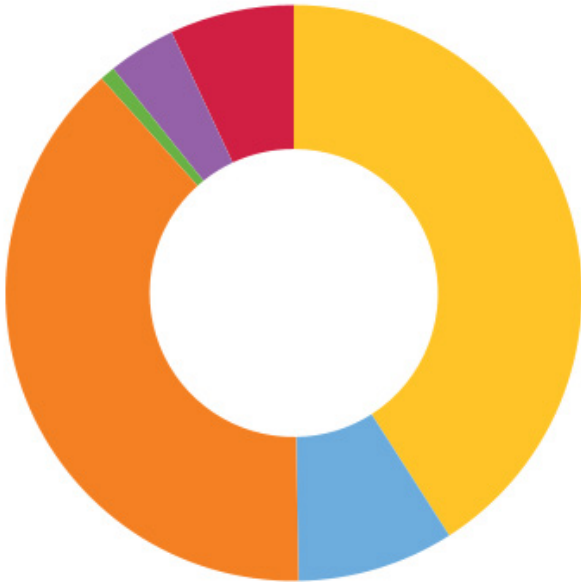

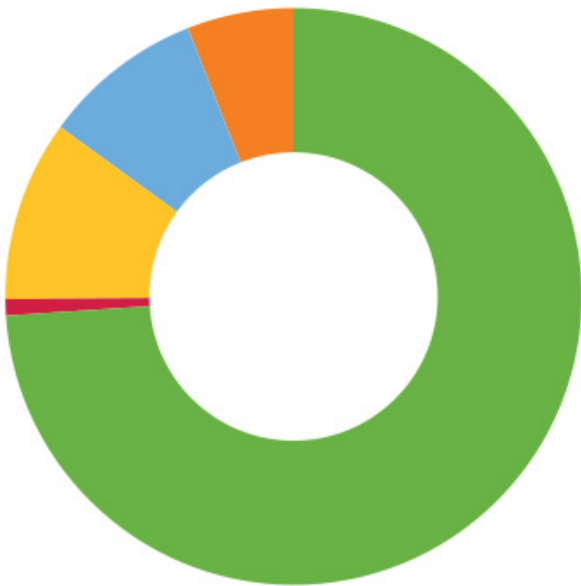

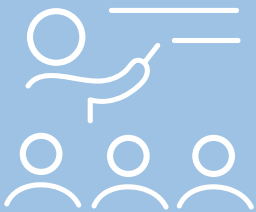
